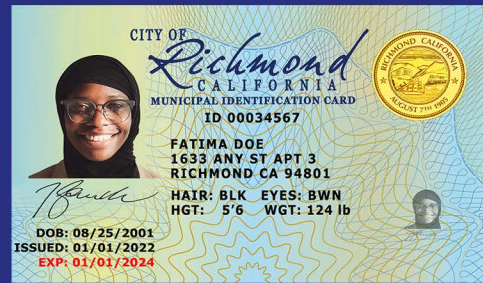
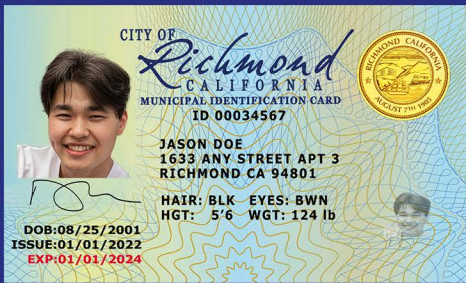




THE RICHMOND CITY ID CARD GOT YOURS?



WHAT ARE THE BENEFITS OF THE RICHMOND ID?

- Accepted by the Richmond Police Department as a valid ID
- Accepted by all City Departments and Agencies as valid ID when doing business with the City
- Accepted by local health care facilities as valid ID for medical/dental services/COVID vaccination
- Accepted for Covered California as valid ID for health insurance enrollment (US citizens and legal residents)
- Accepted by local shelters/housing programs as valid ID
- Accepted as valid ID by Amtrak and Greyhound to purchase tickets and board trains and buses
- Accepted by local financial institutions as a valid secondary ID to open a bank account
- Accepted by DMV as a secondary ID to apply for a California driver license under AB60
- Accepted by Peralta Community College District as valid ID for student enrollment
- Accepted by local food banks and pantries as a valid ID to receive food assistance
- Accepted by local recycling centers as a valid ID
- Accepted by local check cashers as a valid ID to cash your payroll check
- Valid Proof of ID and Age at local businesses selling/serving alcohol (California Department of Alcohol Control. Business and Professions Code Section 25660)
- Valid for 2 (two) years from the date of issuance
- No Social Security number required to apply
- Affordable: Adults 18+ \$25.00
Youth 17 & under \$15.00
Seniors 65+ \$15.00

TO APPLY FOR A RICHMOND ID YOU WILL NEED

1.- ONE (1) IDENTIFICATION DOCUMENT FROM THE FOLLOWING LIST

- US Driver's License
- US State ID
- US Passport
- US Tribal ID
- US Work Permit
- US Military ID
- US Permanent Resident ID Card (Green Card)
- Foreign Government Issued Passport
- Foreign Government Issued National ID Card
- Foreign Government Issued Consular ID Card
- DHS Immigration Case Documentation
- Inmate Release or Parole Documentation

All documentation must be original and with no signs of alterations. Expired documents are acceptable. If more than 1 ID document from this list is provided no additional proof of ID documents are required.

2.- ONE (1) IDENTIFICATION DOCUMENT FROM THE FOLLOWING LIST

- US Social Security Card
- ITIN Taxpayer Identification Number
- US School Photo ID
- US Workplace Photo ID
- Voter Registration Card
- Utility Bill (Water & Power, Internet Service, Cable, Gas, Phone)
- Insurance Bill (Health, Auto, Home, Life, Renter)
- Income Tax Forms (Filing, W2, W9, Refund)
- Birth Certificate
- Lease or Rental Agreement
- Pay Stub
- Bank or Credit Card Account Statement
- Vehicle Registration

Monthly recurrence bills must be dated within 60 days of application date.

3.- ONE (1) PROOF OF ADDRESS IN THE CITY OF RICHMOND

- Pay Stub
- Bank or Credit Card Statement
- Vehicle Registration
- Mortgage Payment
- Lease or Rental Agreement
- Utility Bill (Water & Power, Internet Service, Cable, Gas, Phone)
- Insurance bill (Health, Auto, Home, Life, Renter)
- Homeless Shelter or Housing Programs verification of city residency
- Jury Summons
- Income Tax Forms (Filing, W2, W9, Refund)
- Current California State Driver License
- Property Tax Statement

Monthly recurring documents must be dated within 60 days of application date. Same document can not be used to fulfill multiple requirements. All documentation MUST bear the name of the applicant. If married or a dependent, an applicant can use a proof of address document in the name of his/her spouse, parent or legal guardian upon establishing the familial relationship by providing a Marriage or Domestic Partnership Certificate, Birth Certificate, Adoption Documentation or Legal Guardianship Documents.
